

Submitting your application for the program

➤ Step 1: Online registration

Register for training on the [Admission FP Portal](#)

Print, date and sign (handwritten) the admission form.

➤ Step 2: Filing documents

Gather all the required documents and file the documents in digital format in your [Online file](#)

The digital version must meet the following criteria:

- ✓ Be filed in the section specific to each document
- ✓ Coming from the original document
- ✓ Contain only one (1) document per image
- ✓ Be easily readable
- ✓ The entirety must be visible and the framing must be complete
- ✓ All pages and/or faces (double-sided) are present
- ✓ The document must not be altered or falsified in any way

We invite you to keep the original documents.

Some files may be subject to random auditing and the training centre may require them to be submitted in person. If applicable, you will receive an official communication with the necessary instructions

➤ Step 3: Analysis of the file

Once all the documents have been received, the file can be analyzed. Once your file has been analyzed, you will receive a communication.

<ul style="list-style-type: none"> Possess a high school diploma (SSD) or equivalent; Possess Secondary 4 units in language of instruction, second language and mathematics; Demonstrate successful completion of the General Development Test (GDT); Possess a diploma of vocational studies with equivalent prerequisites; Present a comparative evaluation of studies outside Quebec. The candidate must demonstrate a diploma that meets the required prerequisites; Submit diplomas or transcripts from equivalent studies outside Canada. 	<ul style="list-style-type: none"> Have less than 4 demerit points on your record; Possess a valid Class 5 driver's license; No licence suspension or revocation in the last 2 years following an accumulation of demerit points or a Criminal Code offence committed while driving a vehicle; Demonstrate that your medical condition meets the requirements of the Drivers' Health Regulations. <p>Consult the SAAQ requirements: Obtaining a class 1 licence</p>

	Birth certificate with parents' names (original)
	Academic record (original documents)
	Valid Class 5 driver's license
	Recent driving record (less than one month old)
	The SAAQ letter – medical decision with authorization to obtain a Class 1
	Signed authorization forms (2): SAAQ Authorization and CFTR Authorization
	Immigration documents (if born outside of Canada)
	Proof of residency in Quebec
